CONTRACT: This contract is entered into between _____ (hereafter “Speaker”) and the National Association of Dog Obedience Instructors, Inc. (hereafter “NADOI”) for the purposes of presenting a (seminar / workshop / webinar / etc) (hereafter “Event”) on (date) at (time) at (location).

NOW THEREFORE, in consideration of the representations and warranties set out herein, the receipt and sufficiency of which are hereby acknowledged, Speaker and NADOI agree as follows:

SERVICES: Speaker agrees to present an Event for NADOI pursuant to the RFP attached as Exhibit A to this Contract.

WARRANTIES: Speaker represents and warrants that nothing in the presentation does or will violate or infringe any copyrights, trademarks, patents, or other property rights or personal rights of others. Speaker further warrants that either: (1) the Speaker is the sole author and owner of all rights in the presentation, including all materials included in the presentation; or (2) to the extent the presentation includes materials that are not original to the Speaker, or in which all necessary rights are not owned by the Speaker, the Speaker has obtained all written consents necessary to use the same.

INDEMNIFICATION: Speaker agrees to indemnify, defend and hold harmless, NADOI, its members, officers, directors and agents and attendees and participants of the Event, for any costs, claims or losses, including reasonable attorney’s fees and costs, which may arise, in whole or part, from Speaker’s presentation at the Event.

RECORDING: NADOI reserves the right to record any Event and make said recording available for sale with the necessary copyright to preserve the rights of Speaker. This includes authorization to distribute any materials provided by Speaker in conjunction with the Event.

COMPENSATION AND FEES: NADOI agrees to pay Speaker the sum of \$ _____.00 as compensation for the fulfillment of the RFP attached as Exhibit A. A deposit of \$ _____.00 is due when the Contract is executed and the remainder of the fee is due and payable at the completion of the Event. In the event that Speaker is required to travel to the location of the Event, NADOI will reimburse reasonable expenses to include travel and lodging upon completion of the event and submission of receipts. In the event that said Event is recorded, Speaker will receive compensation of 15% of net sales of said recording, paid annually.

PENALTIES:

In the event that Speaker defaults on his/her commitment to present at the Event, if said default occurs more than 180 days from the scheduled Event, Speaker agrees to return the deposit to

NADOI. If said default occurs within 180 days of the scheduled Event, Speaker agrees to reimburse NADOI for all associated expenses in arranging and promoting the Event.

In the event that NADOI cancels the Event more than 90 days of the scheduled Event, Speaker will retain the deposit. If the cancellation occurs within 90 days of the scheduled Event, NADOI agrees to pay the entire fee to Speaker.

PROMOTION:

Speaker agrees to promote the Event on his/her website and with any professional organization Speaker belongs to at the time the Contract is executed. Speaker further agrees to provide any necessary information to NADOI to enable NADOI to seek continuing education units (CEUs) from other professional organizations in the field.

NADOI agrees to promote the Event on its website and in other venues. NADOI also agrees to place an advertisement, provided by Speaker, for any books or other materials produced by Speaker in its Newsletter for the issues leading up to the Event.
